###. The new offers and prices will apply to existing customers who renew their contracts and to new service requests. No early termination fee or new application will be required of existing customers in order to take advantage of this new pricing.

2. Retail/Wholesale Tariff Pages

Revised tariff pages describing the new prices and speeds are attached to this letter. Consistent with the imputation test set out in Annex 5 of its Licence, LIME will apply a 20% discount to the retail rates to derive the applicable wholesale rates. Term discounts equivalent to the retail term discounts would also be available to wholesale customers. The new wholesale prices are attached to this letter.
