Re: Introduction of New Service

Further to the Authority's letter of 2 April 2009, and pursuant to paragraph 31 of Annex 5 to its Licence, Cable and Wireless (Cayman Islands) Limited, t/a LIME ("**LIME**") applies to the Authority for authorization to offer a new service in the Cayman Islands, ###.

Service Description

LIME notes that the service was described in LIME's 30 March 2009 letter to the Authority.

Service Category

The Authority ruled in its 2 April 2009 letter that the proposed new service ought to be classified as a Category 1 service. LIME does not believe any public interest is actually served by such a categorization. However, LIME wishes to provide the service and accepts the ruling under protest.

Imputation Test

LIME notes that the imputation test for the existing service that the Authority used to determine the category of the proposed new service is based on the "wholesale" price. LIME has prepared a wholesale service offering, at a 20% discount off the proposed retail price. As a result, the rates for the service pass the relevant imputation test.

The Service Schedule for the wholesale service offering is attached (in confidence).

Tariff Pages

Proposed General Tariff pages for the proposed new service are attached for approval.

As noted in our 30 March 2009 letter to the Authority, consequential changes are required in the Tariff Item for ###. LIME hereby applies for approval to amend ### as described in the attached revised Tariff Pages.

Rates and Charges

Rates and charges for the new Service will consist of once-off installation charges of CI\$ ###, and monthly recurring charges of CI\$ ##.

Effective Date

C&W intends to begin offering this service on a commercial basis on ##.

Confidentiality Claim

C&W is filing this application, including the attached Tariff Item pages and wholesale Service Schedule, in confidence with the Authority. The marketing and product development plans of C&W are information that is of a commercial nature and is consistently treated in a confidential manner by C&W until they are implemented. C&W's competitors and potential competitors would gain advance knowledge of C&W's marketing and pricing plans, even before the information could be made available to C&W's customers or to the general public. This would enable them to develop competitive and targeted marketing and pricing responses, even before C&W would be able to implement its own plans.

An abridged version of this letter will be filed. All confidential information in this letter will be replaced by "###". Abridged versions of the Tariff Item pages and Service Schedule will not be provided for the public record, as these would be meaningless.
