The current ### is no longer applicable to the current operating environment and is the subject of accusations of unjustified discrimination. The proposed policy addresses Customer Type rather than nationality and seeks to broaden the business categories in accordance with the issued Government or Statutory Authority Business Licence category. The proposed policy also takes into consideration the ### customers when a ### is required.

Operating Environment

Through informal discussions with you, C&W has expressed its concern with the increased in ###. By restructuring our ### C&W is hoping to, at least, reduce the number of ### it is handling.

C&W notes that the operating environment has changed over the years and has changed significantly since the commencement of liberalization and open competition. Post-storm

inflationary pressures have also been a significant factor in the rise of ### ###. A contributing factor is also the relatively low Reconnection Fee.
