Mr. Young,

Earlier today, the Authority received an additional letter from Christian Communication (CCA) regarding the relocation of the Heaven 97 transmitter out of George Town. You will recall that CCA's letter of 15 September (attached to my e-mail below) requested a one-month extension to the deadline to relocate this transmitter. In today's letter, CCA is proposing to reduce Heaven 97's power level from 2 KW to 1KW in order to mitigate the intermodulation product at 98.9 MHz. I am enclosing a copy of CCA's letter for your reference.

After receiving this letter, the Authority clarified with CCA that this proposed reduction in power level is meant to be temporary, pending the relocation of the Heaven 97 transmitter out of George Town (which, according to CCA's 15 September proposal, would be implemented by the end of October). Once the relocation of this transmitter is complete, CCA is proposing to bring Heaven 97's power level back up to 2KW. Furthermore, CCA is proposing to increase Gospel 88's power level from 250 watts to 2 KW once the Gospel 88 transmitter is relocated out of George Town (which, according to the Authority's determination, must be implemented no later than 15 July 2009).

The Board of the Authority will be considering these proposals at its next meeting on Thursday morning. Should Paramount wish to make submissions on these requests, feel free to do so before 4:00pm tomorrow (24 October).
