Re: Requests to Reduce the Power Level and Extend the Deadline to Relocate the Heaven 97 Transmitter


This letter is to advise you that, on 25 September 2008, the Information and Communications Technology Authority (the "Authority") considered your requests to reduce the power level of Heaven 97 and extend the deadline to relocate the Heaven 97 transmitter. After careful consideration, the Authority made the following determinations:

- (1) In accordance with section 9 of the Information and Communications Technology Authority Law (2006 Revision) and section 6 of the Information and Communications Technology Authority (Interference and Equipment Standardization) Regulations, 2004, Christian Communications Association ("CCA") is hereby ordered to cease and desist from causing intermodulation at 98.9 MHz no later than 30 September 2008. The Authority notes that, in order to eliminate this intermodulation product, CCA can take a number of steps including a reduction in Heaven 97's power level, a change in Heaven 97's frequency from 97.7 MHz to 97.5 MHz and/or a recalibration or adjustment to the Heaven 97 transmission equipment. Alternatively, CCA can cease all transmissions at 97.7 MHz pending the relocation of the Heaven 97 transmitter.
- (2) The Authority's Staff will conduct testing of the FM broadcasting spectrum on 1 October 2008 to confirm that the intermodulation product has been eliminated. Should the Authority's Staff find that there is still a significant amount of intermodulation, the Authority will issue an order requiring that CCA immediately cease all transmissions at 97.7 MHz pending a relocation of the Heaven 97 transmitter.

- (3) The Authority hereby extends the deadline to relocate the Heaven 97 transmitter to 31 October 2008. Gospel 88.7 FM must be relocated no later than 15 July 2009. However, if significant interference is still present in George Town following the relocation of the Heaven 97 transmitter, the Authority reserves the right to order CCA to relocate the Gospel 88.7 FM transmitter prior to 15 July 2009. For your information, the Authority also reserves the right to order dms Broadcasting Ltd. to relocate the Cayrock 96.5 FM transmitter prior to 15 July 2009 if there is still significant interference in George Town following the relocation of the Heaven 97 transmitter.

The Authority notes that it is currently finalizing a formal decision on the proceeding. This decision will provide detailed reasons for these determinations. It is currently anticipated that this decision will be issued by mid October.
