Thank you for your letter of today's date. In answer to your question, please note that section 79(3) of the ICTA Law states that a licensee may apply for reconsideration "within fourteen days of receipt of the decision and written reasons". In the present case, the Authority's decision and reasons were sent, and presumably received by Digicel, on 24 December 2009. Therefore, the period to apply for reconsideration will expire within 14 days of this decision, i.e. on **7<sup>th</sup> January 2009**.

I have copied LIME on this correspondence and I would ask that you please do the same for all future correspondence relating to this dispute.
