Subject: Call for Comments - Digicel application for reconsideration of certain aspects of the Authority's interim determination dated 24 December 2009

The Authority has received a 7 January 2010 application by Digicel for reconsideration of certain matters addressed an Authority determination dated 24 December 2009.

Pursuant to subsection 78(4) of the ICTA Law, a decision must be rendered on the reconsideration application no later than **4 February 2010**. In order to meet this deadline, the Authority sets the following schedule:

- All material filed with the Authority in this proceeding will be posted on the Authority's web site before the close of business on **8 January 2010**;
- Any interested party may file comments on Digicel's application by no later than **18 January 2010**;
- Digicel may file a written reply to any comments received, by no later than **22 January 2010**.

All submissions filed in this proceeding should be copied to the other parties at the same time they are submitted to the Authority. If any information is filed in confidence with the Authority, it must be done so in accordance with the ICTA Confidentiality Regulations.

The Authority will not formally acknowledge comments. It will, however, fully consider all submissions and they will form part of the public record of the proceeding, provided that the procedures for filing set out above have been followed.
