- Class of License are defined in Section 3 of the [ICT \(Amateur Radio Licences\), 2010 Revision](#).
- You should use this form (ICT Form J) if you wish to apply for, or renew an Amateur Radio Licence.
- This form must be accompanied by:
 - The Appropriate fee (currently CI\$20/US\$25), and
 - Photo Identification, and
 - Copy of current home Amateur License (where applicable), on initial application or change of class, or
 - Copy of current certificate from the Cayman Amateur Radio Society (where applicable), on initial application or change of class.
