**Re: Public Consultation on Costing Manual - CD 2005-1**

Attached are further interrogatories by the ICTA's external consultant, Telcordia Technologies, Inc. ("Telcordia"), to C&W.

Question 1 in Section 3.1 Model Errors requests that C&W provide revised versions of both the fixed and the consolidated models, correcting the numeric and formula errors in the models that were identified in the previous interrogatories and acknowledged by C&W in its responses. That same question also requests that C&W provide a list of all the changes made with the revised versions. C&W is requested to provide these revised versions as soon as possible, but no later than 23 April 2007, so that the ICTA's external consultant can continue its evaluation.

C&W is requested to provide responses to the other questions in the Telcordia document labelled Attachment 1 by 16 May 2007.
