Following last year's public consultation on local number portability, the Authority's decision has now been published on our web site at http://www.icta.ky/da\_publications.php#decisions. You will note that the decision requires, amongst several matters, that operators licensed to provide telephony services (Type 1, 3, 4 and 5 Services) implement LNP no later than 30 June 2010. In addition, the decision also requires that the LNP Consortium provide a report for approval to the Authority by 29 May 2009 that describes a recommended LNP solution and provides a detailed implementation plan and milestones.

In order to assist with this process, I would be grateful if each licensee would nominate one or two representatives to be a member of the LNP Consortium, by return e-mail no later than 23 January 2009.
