Further to the Authority's letter of 14 January 2010 and to ICT Decision 2010-2, Cable and Wireless (Cayman Islands) Limited, trading as "LIME" ("**LIME**") is attaching the following documents to be placed on the public record.

- 10_01_28 Appendix VIII – RF analysis revised – revised redaction (int 121).xls
- 10_03_11 Appendix V-TD LRIC Input 07-04-09 conf_revised – revised redaction (int 120).xls
- CYM Mobile 2G – updated 10_03_11 revised redaction.xls
- CYM Mobile 3G – updated 10_03_11 revised redaction.xls.

LIME is also filing CYM Fixed – updated 10_03_11 revised redaction.xls. This was to address an inconsistency in the data in the "overhead_exp" tab cross-referenced from the other models. For convenience, all three redacted models are included in the same ZIP file.

Finally, we will be filing with the Authority alone, under separate cover, an updated version of the confidential 3G model, CYM Mobile 3G – updated 10_03_11.xls. In November 2009, we inadvertently did not update the figures in cells G9:AA9 of the "overhead_exp" tab when the source of that information, the confidential version of the fixed model, had itself been updated. For convenience, we will include all three confidential models in a single ZIP file.
