Dear Licensees,

This is to confirm that the Authority expects to receive reply comments in the above-mentioned proceeding by **Friday September 10th at 5:00pm**. Please keep in mind that this deadline is shorter than the 20-day deadline in section 6(2) of the Dispute Resolution Regulations. However, based on the discussions last week, it is my understanding that the Consortium has decided to abide by this shorter deadline.

Once again, we will require confirmation from each operator that:

- you agree that the parties have reached an impasse on the voting rights for local number portability;
- you wish to have the Authority adjudicate this matter, in accordance with the Dispute Resolution Regulations; and
- you have provided complete submissions to the Authority and do not intend to make further submissions.

I would ask that you please provide this confirmation as part of your reply comments on Friday. If you choose not to file reply comments, feel free to provide this confirmation by return e-mail.

Separately, I can confirm that the Authority has approved three changes to NXX allocations since we issued our cost-sharing decision in mid July: (1) one NXX has been added to the Digicel licence; (2) two NXX's have been deleted from the WestTel licence; and (3) two NXX's have been deleted from Infinity's licence. All of these licence amendments were approved by the Authority on July 28th. Therefore, effective July 28th, the cost-sharing formula for LNP is as follows:

Please note that you will need to pay the \$750 fee twice, i.e. once for the voting rights dispute and once for the vendor selection dispute. If you paid your share of the CI\$750 fee using the pre-July 28 formula (e.g. Digicel), please send us a cheque for the difference.
