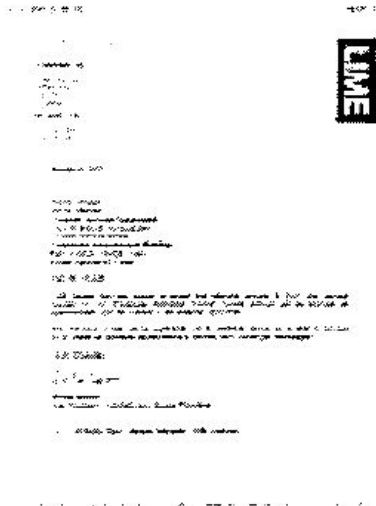
Thanks for providing the revised special tariff pages and the copy of the emails.
There are two, hopefully minor, items:

1) Special Tariff pages: Item 204.4.c) now says "for contracts signed on or after 14 December 2010 and before 1 January 2012" and Item 204.4.d) says "for contracts signed on or after 1 January 2012". According to the effective date, both of those "1 January 2012" references should be to "9 January 2012". Please correct the effective date and update the website.

2) The copies of the emails that were provided identified "2 attachments" and included thumbnails (see below) of the "DIA January 2012 Wholesale Pricing.pdf" document that was sent to the wholesale customers, but I am unable to read the text of that document. Please provide legible copies of the two attachments that were sent.

Dear Mr. Connors,

Please find enclosed revised pages for Special Tariff Item 204. These reflect the changes you proposed in your email of 30 December 2011. We have also chosen to delete the rates at what had been subparagraph 204.4(a) (and to renumber the remaining subparagraphs in paragraph 204.4 accordingly) as no customers remain on those pre-1 July 2007 rates.

Because of the Christmas holidays and the unavailability of personnel, no carriers were advised of the new wholesale rates prior to 1 January 2012. In order to remain compliant with ICT Decision 2006-3, LIME have deferred the implementation of the lower retail and wholesale rates until 9th January. On the 8th January, Carrier Services contacted its wholesale customers (please see copy of correspondence attached) and the new tariff pages will be posted to the LIME website this evening.
