



AMENDMENT NO. 12 TO THE LICENCE OF WESTSTAR TV LTD.

WHEREAS WestStar T.V. Ltd. was granted a Licence by the Information and Communications Technology Authority (the 'Authority'), dated 10 October 2003 (as amended);

AND WHEREAS WestStar T.V. Ltd. is required under the terms of Annex 1A of its Licence to deploy and offer a domestic fibre optic cable network (Type D1) no later than 31 December 2012;

AND WHEREAS WestStar T.V. Ltd. has requested extensions to this rollout date;

AND WHEREAS the Authority considers that, in light of the submissions filed by WestStar T.V. Ltd., it is appropriate to extend the roll out dates as set out in the attached Annex;

THEREFORE, pursuant to sections 23 and 31 of the Information and Communications Technology Law (2011 Revision), Annex 1A of the WestStar T.V. Ltd. Licence is hereby amended.

Annex 1A

Roll Out Plan

Cable TV Service

Cable television service, using digital technology, (Digital Cable service) will be offered on Grand Cayman no later than 1 March 2003. Digital Cable service shall be offered to the Sister Islands no later than 6 months from the date on which the Licensee has achieved a minimum of 1,000 subscribers in the Sister Islands. On the 31st of January of every year (or the following business day, if the 31st of January falls on a weekend or statutory holiday), the Licensee shall provide status reports to the Authority on its number of subscribers in the Sister Islands and on the estimated cost of rolling out digital cable TV in the Sister Islands using technologies available at that time. The Authority reserves the right to require the Licensee to rollout digital cable TV in the Sister Islands, irrespective of the number of subscribers, if the Authority determines that the rollout of this service has become cost-effective.

The Licensee shall make every effort to deploy and offer in Grand Cayman its Fibre optic cable network and make available ICT Services over that network in accordance with the following timetable:

- a) by 30 June 2012: complete a fibre network sufficient to enable the provision of ICT Services to 10% of the resident population of George Town;
- b) by 31 December 2012: complete a fibre network sufficient to enable the provision of ICT Services to 60% of the resident population of George Town and to 10% of the resident population of West Bay;
- c) by 30 June 2013: complete a fibre network sufficient to enable the provision of ICT Services to 100% of the resident population of George Town, to 70% of the resident population of West Bay, and to 10% of the resident population of Bodden Town;
- d) by 31 December 2013: complete a fibre network sufficient to enable the provision of ICT Services to 100% of the resident population of George Town and West Bay, to 60% of the resident population of Bodden Town, and to 10% of the resident population of Northside and East End;
- e) by 30 June 2014: complete a fibre network sufficient to enable the provision of ICT Services to 100% of the resident population of George Town, West Bay and Bodden Town, and to 50% of the resident population of Northside and East End; and,

- f) by 31 December 2014: complete a fibre network sufficient to enable the provision of ICT Services to 100% of the resident population of Grand Cayman.

No later than fifteen (15) calendar days following the end of each quarter, the licensee shall provide status reports to the Authority on the rollout of its fibre optic cable network.
