Further to Mr. Dave Archbold's email, please find attached a revised public version of Appendix X. To make the extracts more legible, they were enlarged and placed at the end of the document in landscape format (appropriate corresponding references are added to the body of the text as well where necessary). We made no other change to Appendix X.

Please note that Fixed Model Case Study filed as Appendix X on 23 February 2007 is the same Fixed Model Case Study originally filed in March 2006 but with numbers in the text amended to correspond to the confidential model as was requested in Interrogatory 3.12.2. Although from the confidential model, C&W did not believe the numbers in the text would be prejudicial, so included them in the Case Study circulated to all interested parties. However, screen shots of the confidential model results would have been prejudicial and therefore we retained the screen shots as they appeared in the original March 2006 filing. The numbers in the text and the numbers in the screen shots are therefore not necessarily consistent.

We are now supplying the Authority, by separate email, a confidential version of the Case Study which has screen shots from the confidential model with numbers that are consistent with the numbers in the text.
