LIME's 17 March 2009 letter stated that it did "not expect any parties to be materially disadvantaged by this delay" and the Authority received no comments or requests for extension on other time lines. Therefore, at this point, no other time lines have been moved.

As LIME has indicated that it expects to be able to file all other required material on 6 April 2009, I suggest that parties begin their review of that material and then, once LIME's 3G submission is received by 18 May 2009, parties should evaluate whether they can complete their review and submission regarding that model by the 7 July 2009 time frame.

The Authority would hope that parties can file their submissions within the already identified timeframes but does realize that the six-week delay to the filing of the 3G model may prove to be a challenge in meeting those timelines.
