David,

There are a couple of other matters from the Consortium's deliberations that I would like to bring to the attention of the Authority.

The LNP Consortium reached a consensus that it would be beneficial to hire a third-party consultant to assist with the development of the RFP, the review of technical solutions and the implementation of the preferred solution. The Consortium felt the expertise of this third party would help the members of the Consortium make a proper assessment of the available NP solutions that which would applicable to the Cayman market. However, none of the members are in a position to engage or remunerate such an expert.

The Technical Committee of the Consortium also considered the impact of the implementation of direct interconnection between mobile operators. However, no consensus was reached on whether this would facilitate the porting of all mobile services, or whether this would introduce a level of complexity that would hinder the successful implementation of number portability.
