Interrogatories regarding LIME's submissions in the FTR and Transit Rate Proceeding — CD2012-1

The Information Communications and Technology Authority (the "Authority") is continuing its detailed review of the FLLRIC cost model and materials submitted by Cable and Wireless (Cayman Islands) Ltd ("LIME"). In order to facilitate its analysis, the Authority requires LIME to provide responses to the questions in the Attachment. Please provide responses to the interrogatories by **7 March 2013.**

When responding, please repeat the entire question above the corresponding response to each question. In addition, responses should be made in compliance with the procedures specified in the Authority's 13 December 2012 letter.

When submitting any revised versions of the FLLRIC cost model, LIME is directed to provide all modules and all linked spreadsheets with fully functional links between them. Further, each spreadsheet and module should be identifiable by a version number.

At this time, the Authority is providing the Attachment in confidence to LIME. However, in order to help keep interested parties to this proceeding properly informed and to provide LIME with an opportunity to redact the portions of the questions that it considers confidential, LIME is directed to follow the procedures specified below.

If LIME considers any of the information in the interrogatories to be confidential, it is to provide a redacted version of the Attachment, along with any confidentiality claim to the Authority by **21 February 2013** with copies sent to the distribution list for this proceeding at the same time the redacted version is submitted to the Authority. If LIME does make a confidentiality claim, it must do so in accordance with the *ICTA* (*Confidentiality*) *Regulations*, *2003*.

If LIME does not consider any of the information in the interrogatories to be confidential, it is to make a revised version of the Attachment by removing the "Confidential" indications. The revised version should be provided to the Authority by **21 February 2013** and copied to the distribution list for this proceeding at the same time the revised version is submitted to the Authority.
