



**AMENDMENT NUMBER 18 TO THE LICENCE OF
CABLE & WIRELESS (CAYMAN ISLANDS) LIMITED, doing
business as 'LIME'**


WHEREAS Cable & Wireless (Cayman Islands) Limited, doing business as 'LIME', is currently authorised under the terms of its licence granted by the Information and Communications Technology Authority on 10 July 2003, to supply various Information and Communications Technology ('ICT') Networks and offer various ICT Services;

AND WHEREAS Cable & Wireless (Cayman Islands) Limited has requested permission from the Information and Communications Technology Authority to provide Type 6 (Public Service Television Broadcasting) and Type 7 (Subscription Television Broadcasting) ICT Services;

AND WHEREAS the Information and Communications Technology Authority concurs to this request;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2011 Revision), Annex 1 *Licensed ICT Networks and ICT Services* of Cable & Wireless (Cayman Islands) Limited's Licence is hereby amended.

- 1.3 The Authority shall have the right to impose upon the Licensee additional obligations concerning the Type 6 ICT Service which may include obligations pertaining to such matters as programming and content. The Licensee agrees that the Authority shall have the right to impose obligations, from time to time, as are deemed advisable by the Authority. The intent is for the Licensee to have similar, but not necessarily identical, obligations as any other Licensee offering a Type 6 ICT Service.

At a minimum these obligations shall involve the following:

- a) Any customer wishing to receive the Licensee's Public Television service shall be provided such service, either via wire line or broadcast technology, within a reasonable time frame and at no cost to the subscriber. This includes all manner of device required to provide service into the subscribers premises.
- b) Program content shall, at a minimum, be 20% local content which shall include such items as local talk shows, educational, cultural and religious programming, live sporting events, government information services and live coverage of the proceedings of the legislature.
- c) Public Television service shall involve programming offered 24 hours a day, 7 days a week, 365 days a year.
