



## **AMENDMENT NUMBER 25 TO THE LICENCE OF DIGICEL CAYMAN LIMITED**

**WHEREAS** Digicel Cayman Limited ("Digicel") was granted a Licence by the Information and Communications Technology Authority, dated 17 October 2003 (as amended) (the "Licence");

**AND WHEREAS** Digicel is currently authorised, under the terms of its licence, to supply various Information and Communications Technology ("ICT") Networks and ICT Services;

**AND WHEREAS** Digicel has requested permission to modify the percentage of local content to be provided pursuant to its Type 6 ICT Service, from 50% to 20%;

**AND WHEREAS** the Information and Communications Technology Authority concurs to this request;

**THEREFORE** pursuant to sections 23 and 31 of the Information and Communications Technology Law (2011 Revision), Annex 1 *Licensed ICT Networks and ICT Services* of Digicel's Licence is hereby amended.

1.3 The Authority shall have the right to impose upon the Licensee additional obligations concerning the Type 6 ICT Service which may include obligations pertaining to such matters as programming and content. The Licensee agrees that the Authority shall have the right to impose obligations, from time to time, as are deemed advisable by the Authority. The intent is for the Licensee to have similar, but not necessarily identical, obligations as any other Licensee offering a Type 6 ICT Service.

At a minimum these obligations shall involve the following:

- a) Any customer wishing to receive the Licensee's Public Television service shall be provided such service, either via wire line or broadcast technology, within a reasonable time frame and at no cost to the subscriber. This includes all manner of device required to provide service into the subscribers premises.
- b) Program content shall, at a minimum, be 20% local content which shall include such items as local talk shows, educational, cultural and religious programming, live sporting events, government information services and live coverage of the proceedings of the legislature.
- c) Public Television service shall involve programming offered 24 hours a day, 7 days a week, 365 days a year.
