The Authority has received a request for an extension of the deadline to file submissions in accordance with paragraph 55 of the decision on Deep Packet Inspection issued on 23 March 2010. The Authority has determined that this request is reasonable and hereby extends the deadline to **26 April 2010**.

The Authority reminds the parties that this process is an opportunity for Digicel, LIME and WestTel to argue why, in their opinion, their use of DPI complies with clause 12 of the licence. Alternatively, Digicel, LIME and WestTel can acknowledge that their use of DPI breaches clause 12, and explain how they intend to rectify this breach. Following this, the Authority will issue a final determination on whether there is in fact a breach of clause 12 and/or whether the remedial action proposed by the licensees is sufficient.

Lastly, the Authority would like to point out a mistake in the numbering of the decision sent to the parties on 23 March 2010. This decision should have been numbered "ICT Decision 2010-4" rather than "ICT Decision 2010-3". An updated version of the decision is attached to this e-mail and will be uploaded to the ICTA web site shortly. Please discard the previous version, in order to avoid any confusion.
