






7. COO report

Christen Suckoo gave highlights of report:

- Recruitment: Human Resources/Operations Management. Meeting as a panel, with offer out tomorrow 15 December, or Saturday 16 December. Director of Economics and Regulatory Affairs (DERA). Negotiating salary. Deputy ExDir water (DEDW) is to be re-advertised.
- Consumer Council. Advert for general members and a Chairman specifically will run tomorrow Friday 15 December then January 2024 and close on 21 January.
- Regulatory Impact Assessments to be implemented in January 2024.

- Website now has active online applications and payments for aircraft radio licences. Once all the bugs are worked out this will be expanded to ship radio licences and all other categories.
- IT: plan to move away from Apple to PC. DB to be replaced with a document management system. We are reviewing the strategy and moving pieces of it forward in-house. To be re-evaluated to see how much will require a consultant, once the present work is concluded.
