

# Application for Maritime Mobile ICT Licence

(Type L2, L3 or L4)

Cayman Island registered Vessels requiring an MMSI.



## Instructions for Completion

- Print clearly – illegible, unclear or incomplete application forms may delay processing. Unless otherwise stated, **all sections are mandatory** and must be completed.
- Licence Types are defined in a Section 23 Notice published from time to time in the Gazette by the Office, a copy of which is available on the Office's web site at [www.ofreg.ky](http://www.ofreg.ky).
- You should use this form (OfReg Form L234) if you wish to apply for or renew a Maritime Mobile (ICT) Licence for a Cayman Islands registered vessel which requires an MMSI.
- You may find informative to read the accompanying "Guidance Notes for Applicants" which can be found on the Office's website (<https://ofreg.ky/forms-and-fees> - see under Radio Application Forms) before completing this document.
- Note that it is a serious offence to use radio equipment without a licence. Section 82 of the Information and Communications Technology Act provides for significant fines and confiscation of equipment for those caught.

## Accompanying Documentation

- For **new** applications, this form must be accompanied by:
  - The appropriate application fee;
  - A copy of the Certificate of British Registry issued by the Cayman Islands Shipping Registry
  - A copy of the Appointment of Authorised Officers/Agents
- Changes in Ownership or vessel Callsign are treated as new applications and must be accompanied by all the documents listed above including the full application fee.
- Note that a change of Callsign will result in the issue of a new MMSI.
- Changes in any other details (including de-registration, changes to equipment, owner's name and address or emergency contact) should be notified immediately to the Office using this form.
- Before renewing your licence, you are encouraged to check the details of your vessel as recorded on the International Telecommunication Union (ITU) MARS database (<https://itu.int/mmsapp/ShipStation/list>) and to incorporate any corrections into your application.
- Renewals require this application form to be completed in full and be accompanied by the appropriate application fee.

- **Q17:** A maximum of five EPIRB codes can be provided. Please provide the **15-character hexadecimal** EPIRB/PLB identification code. Note that the Cayman Islands does not maintain an EPIRB database. It is the Owner’s responsibility to register these codes with the UK, USA or other authorities. The MID (Country Code) programmed into the EPIRB is the country where the EPIRB has been registered: this is not the Cayman Islands.
- **Q18:** The Emergency Contact Details should be for a contact **onshore**. You are also asked to provide an alternative 24-hour emergency telephone number. This information is **mandatory** and is available to search-and-rescue authorities in the event of an emergency.
