The Licensee is authorized to supply the following ICT Services as defined by the Authority under the provisions of section 23(2) of the ICTA Law and published in a Notice in the Gazette:

The Licensee is authorized to operate the following ICT Networks as defined by the Authority under the provisions of section 23(2) of the ICTA Law and published in a Notice in the Gazette:

Type B	Fixed Wireless	10 Years
Type C 3	Mobile (Cellular) 3G	10 Years

* The Licence Commencement Date for the Type C2 and S ICT Networks and the Type 3 Mobile Telephony ICT Service was 10 February 2005. All other Networks and Services are licensed from 9 February 2006.

Roll Out Schedule

ICT SERVICES

Full CDMA (850 MHz) service will be made available in Grand Cayman by 1 April 2006 and in the Sister Islands by 1 December 2006.

Limited CDMA (1900 MHz) service for roaming customers will be made available in selected parts of Grand Cayman by 1 April 2006.

Internet Service Provider (ISP) services will be provided by January 07

Provision of ICT Infrastructure to 3rd Parties will be available by January 07

Retail Sale of ICT Equipment will commence by May 06

Application Service Provider (ASP) services will commence by October 06

Video on Demand services will be made available by August 06

ICT NETWORKS

The Licensee will implement a full CDMA (850 MHz) network in Grand Cayman by 1 April 2006 and in the Sister Islands by 1 December 2006.
