Full CDMA (850 MHz) service will be made available in Grand Cayman by 1 October 2006 and in the Sister Islands by 1 October 2007.

Limited CDMA (1900 MHz) service for roaming customers will be made available in selected parts of Grand Cayman by 1 April 2006.

Internet Service Provider (ISP) services will be provided by 31 January 2007.

Provision of ICT Infrastructure to 3rd Parties will be available by 31 January 2007.

Retail Sale of ICT Equipment will commence by 31 December 2006.

Application Service Provider (ASP) services will commence by 31 October 2006.

Video on Demand services will be made available by 31 October 2006.

The Fixed Wireless Network will be in place no later than 30 September 2006 in Grand Cayman and 31 December 2006 in the Sister Islands.

The Mobile Network will be in place no later than 30 September 2006 in Grand Cayman and 31 December 2006 in the Sister Islands.

The Fibre Optic Cable Network (Domestic) will be in place no later than 30 April 2007 in Grand Cayman.

The Fibre Optic Network (International) will be in place no later than 30 April 2007 in Grand Cayman

The International Satellite Network will be in place no later than 30 September 2006 in Grand Cayman and 31 December 2006 in the Sister Islands.

ASP Services will be made available no later than 30 September 2006 in Grand Cayman and 31 December 2006 in the Sister Islands.
