In a 4 February 2010 letter, LIME submitted an application requesting reconsideration of an ICTA determination, dated 14 January 2010 (the "Decision"), regarding Deep Packet Inspection and similar technologies ("DPI"). The Authority hereby calls for submissions on LIME's reconsideration request and sets the following procedures:

- Parties are invited to file comments on LIME's application and, in particular, are requested to address the following:
 - whether the Authority has jurisdiction, under section 78 of the Law or otherwise, to reconsider the Decision; and

- assuming that the Authority has jurisdiction, whether the Decision should be confirmed, reversed or modified, and for what reason(s).
- Comments on the application must be received by the Authority no later than **15 February 2010**. A copy of the comments is to be provided to the DPI distribution list at the same time they are sent to the Authority.
- LIME may file a reply to any comments received concerning its application. Any reply should be filed with the Authority, and copied to the FLLRIC distribution list, by no later than **19 February 2010**.

The Authority will not formally acknowledge comments. It will, however, fully consider all submissions and they will form part of the public record of the proceeding, provided that the procedures for filing set out above have been followed.
