#### Re: Introduction of New Service

Pursuant to paragraph 31 of Annex 5 to its 10 July 2003 ICT Licence (the "**Licence**"), Cable and Wireless (Cayman Islands) Limited, t/a LIME ("**LIME**") applies to the Authority for authorization to offer a new service in the Cayman Islands for business customers called # # (the "**Service**").

## Service Description

#. The Service will be offered on a minimum one -year contract term basis.

### **Service Category**

The Authority has stated in prior correspondence that it does not view this as a new Service, and therefore would categorize it as a Category 1 service. LIME continues to disagree with this view, as there is a fundamental and qualitative difference between a service, on the one hand, that #

#, and another service, on the other hand, that

#. LIME notes that
the market understands LIME's view, as customers are increasingly demanding the
service LIME is proposing to introduce, even though # # continues to be





readily available from LIME (and other providers) to all business customers in the Cayman Islands and should, in the Authority's view, be an adequate substitute.

Notwithstanding the foregoing, and without prejudice to LIME's view that this is not a Category 1 service, LIME reluctantly accepts Category 1 regulation of this otherwise competitive and discretionary service. The alternative would be continued inability to bring this service to business customers in the Cayman Islands.

#### **Imputation Test**

Pursuant to paragraph 46 of Annex 5 to LIME's ICT Licence, and pursuant to the Authority's view that the Service is "very similar, if not identical" to # #, the relevant imputation test is the wholesale price for the service. The wholesale prices are set out in the confidential Attachment 1 to this letter, and the applicable Service Schedule to the Service Provider Agreement is attached, in confidence, as well.

Other licensed operators in the Cayman Islands will be notified of the new service and prices on or before the day LIME commercially launches the retail Service.

#### **Confidentiality Claim**

This application and its attachments are filed under confidential cover. The marketing and product development plans of LIME's information that is of a commercially sensitive nature and is consistently treated in a confidential manner by LIME until implementation. In the event the information were to be treated otherwise, LIME's competitors and potential competitors would gain advance knowledge of LIME's marketing and pricing plans, even before the information could be made available to LIME's customers or to the general public. This would put LIME at a competitive disadvantage.
