



AMENDMENT NUMBER 13 TO THE LICENCE OF DIGICEL CAYMAN LIMITED

WHEREAS Digicel Cayman Limited ("Digicel") is authorized, pursuant to the terms of its ICT Licence, to offer service as an Internet Service Provider;

AND WHEREAS Digicel has requested that its Licence be amended to include additional spectrum at 8.029 to 8.043 GHz (uplink) and 8.295 to 8.309 GHz (downlink) in order to increase backhaul capacity for its WIMAX service;

AND WHEREAS Digicel anticipates that it will require this spectrum for a period of six months;

AND WHEREAS the Information and Communications Technology Authority concurs to amending Annex 4 of Digicel's Licence;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2006 Revision), Annex 4 of the Digicel's Licence is hereby amended.

** The Licensee is authorized to use these frequencies from 28th October 2010 to 28th April 2011. If the Licensee wishes to continue using these frequencies after 28th April 2011, it must apply for, and receive, prior approval from the Authority to continue using these frequencies.

Type S Spectrum

The number of transmission channels employed is to be specified by the licensee each year.
