



AMENDMENT NUMBER 16 TO THE LICENCE OF DIGICEL CAYMAN LIMITED

WHEREAS Digicel Cayman Limited ('Digicel') is currently authorized under the terms of its licence granted by the Information and Communications Technology Authority on 17 October 2003, to supply various Information and Communications Technology ('ICT') Networks and offer various ICT Services;

AND WHEREAS the Information and Communications Technology Authority published on 13 May 2011 an updated notice under section 23 (2) of the Information and Communications Technology Authority Law (2010 Revision) ('Section 23 Notice') specifying which types of ICT Networks and Services are required to be licensed;

AND WHEREAS the Information and Communications Technology Authority seeks to reflect the licensed types of ICT Network and ICT Services as set out in the Section 23 (2) Notice in Annex 1 of Digicel's Licence;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Authority Law (2010 Revision), Annex 1 of Digicel's Licence is hereby amended.
