



AMENDMENT NO. 6 TO THE LICENCE OF DMS BROADCASTING LTD

WHEREAS dms Broadcasting Ltd. has finalized a marketing plan which allocates a new name to Style 96.5 FM which necessitates amending both Annexes 1A and 4 as these Annexes reference name will not be utilized;

AND WHEREAS dms Broadcasting Ltd. was granted a Licence dates 15 July 2004;

AND WHEREAS the Information and Communications Technology Authority concurs to amending Annexes 1A and 4 of the said Licence to reflect the new name for Style 96.5 FM;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2004 Revision) Annexes 1 A and 4 of the dms Broadcasting Ltd. Licence dated 15 July 2004 are amended whereby the reference to Style 96.5 FM will be replaced with CAYROCK 96.5 FM in Annex 1A in relation to deployment to Grand Cayman, Little Cayman and Cayman Brac; and in Annex 4 in relation to frequency.

ICT Network

The Licensees ICT Network will be fully deployed to Grand Cayman by 1 June 2005. The ICT Network offering CAYROCK 96.5 FM and HOT 104.1 FM will be deployed to Cayman Brac and Little Cayman by 30 April 2007.

ICT Services

The Licensees ICT services identified as CAYROCK 96.5 FM (formerly Style 96.5 FM), Hot 104.1 FM, KISS 106.1 FM, and X 107.1 FM were fully deployed on Grand Cayman at the date of this amendment.

CAYROCK 96.5 FM and HOT 104.1 FM will be deployed to the Sister Islands by 30 April 2007.

Type S Licence

Type S Licences are issued annually on the basis of the number of transmission channels employed by the licensee.

* The requested assignment of the ICT Licence of CAYROCK 96.5 FM (formerly Style 96.5 FM Ltd.) to dms Broadcasting Ltd. is hereby granted, subject to the conditions that the present antenna location and effective radiated power be maintained, to be changed only upon approval of a subsequent application to the Authority. Furthermore, the frequency of 96.5 MHZ is itself subject to change, should the Authority, in consultation with Cayman radio broadcasting community, determine to pursue further the initiatives to harmonize assigned frequencies at fourth or third adjacent, as discussed at the meeting held on 20 April 2006.
