

## AMENDMENT NO. 15 TO THE LICENCE OF INFINITY BROADBAND LTD.

**WHEREAS** Infinity Broadband Ltd. was granted a Licence by the Information and Communications Technology Authority (the 'Authority'), dated 13 December 2004 (as amended).

**AND WHEREAS** Infinity Broadband Ltd. is authorised under the terms of its Licence to provide various ICT Services as set out at Annex 1 of its Licence;

**AND WHEREAS** Infinity Broadband Ltd. has requested to be licensed to provide Type 11 ICT Service — *The provision, by lease or otherwise, of ICT infrastructure other than dark fibre to a Licensee*;

**AND WHEREAS** the Authority concurs to amending Annex 1 *Licensed ICT Networks and ICT Services* of as Infinity Broadband Ltd.'s Licence as requested;

**THEREFORE,** pursuant to sections 23 and 31 of the Information and Communications Technology Authority Law (2011 Revision), Annex 4 of the Infinity Broadband Ltd. Licence is hereby amended.

## 1 LICENCED ICT NETWORK AND ICT SERVICES

1.1 The Licensee is authorized to operate the following ICT Networks as defined by the Authority under the provisions of section 23(2) and published in a Notice in the Gazette:

1.3 The Authority shall have the right to impose upon the Licensee additional obligations concerning the Type 6 ICT Service which may include obligations pertaining to such matters as programming and content. The Licensee agrees that the Authority shall have the right to impose

obligations, from time to time, as are deemed advisable by the Authority. The intent is for the Licensee to have similar, but not necessarily identical, obligations as any other Licensee offering a Type 6 ICT Service.

At a minimum these obligations shall involve the following:

- a) Any customer wishing to receive the Licensee's Public Television service shall be provided such service, either via wire line or broadcast technology, within a reasonable time frame and at no cost to the subscriber. This includes all manner of device required to provide service into the subscribers premises.
- b) Program content shall, at a minimum, be 30% local content which shall include such items as local talk shows, educational, cultural and religious programming, live sporting events, government information services and live coverage of the proceedings of the legislature.
- c) Public Television service shall involve programming offered 24hours a day, 7 days a week, 365 days a year.
- d) The Licensee shall construct a studio for its local content programming at a cost of no less than CI \$400,000.00.
