Re: Filing of Variation Agreement between Cable and Wireless (Cayman Islands) Limited and Digicel Cayman Limited and Claim for Confidentiality

Pursuant to regulation 22(1) of the *Information and Communications Technology Authority (Interconnection and Infrastructure Sharing) Regulations, 2003* and section 66 of the *Information and Communications Technology Authority Law (2011 Revision)* Cable and Wireless (Cayman Islands) Limited, trading as LIME (“**LIME**”) hereby submits to the Authority, the enclosed Variation Agreement dated September 19th, 2012 and two versions of the revised tariff schedule, with respect to Interconnection Agreement dated the 28th day of February, 2011 between LIME and Digicel Cayman Limited (“**Digicel**”). This Variation Agreement implements the Authority’s determination in ICT Decision 2012-2.

Confidentiality claim

Pursuant to regulation 3 of the *Information and Communications Technology Authority (Confidentiality) Regulations, 2003* (“**the Confidentiality Regulations**”) LIME requests confidential treatment of the Joining Service charges contained in the Tariff Schedule. As provided by section 3(b) of the Confidentiality Regulations, these charges are commercial information that is treated consistently in a confidential manner by LIME and the information is not otherwise publicly available.

As the Authority is aware, the Joining Service charges are bespoke. They reflect the interconnection facilities and services specific to each operator with whom LIME interconnects. If this information in the Tariff Schedule attached hereto were to be made public, it would allow competitors to better understand the traffic and the plans of both LIME and of Digicel, to the financial and competitive detriment of both LIME and Digicel.

Accordingly, further to regulation 4 (1) (c) of the Confidentiality Regulations, LIME has enclosed, as above-mentioned, two versions of the revised tariff schedule: a confidential version of the revised Tariff Schedule for the Authority, and a redacted version of the said document for the public record.

BETWEEN

- A) Digicel Cayman Limited, a company duly incorporated under the laws of the Cayman Islands, having its registered office at 3rd Floor, Cayman Financial Centre, P.O. Box 700, Grand Cayman, KY1-1107 (“**Digicel**”); and
- B) Cable and Wireless (Cayman Islands) Limited, trading as LIME, a company duly incorporated under the laws of the Cayman Islands, having its registered office at One Technology Square, PO Box 293, Grand Cayman, KY1-1104 (“**LIME**”).

WHEREAS

- A) Digicel and LIME executed an Interconnection Agreement dated the 28th day of February, 2011 (the “**Interconnection Agreement**”).
- B) The Information and Communications Technology Authority (the “**Authority**”) determined a cost-oriented mobile termination rate in ICT Decision 2012-2 on 17 May 2012.

THEREFORE the Parties agree as follows:

1. The Parties agree to replace the existing Tariff Schedule of the Interconnection Agreement with the attached revised Tariff Schedule (version 2.1), effective as of 17 May 2012.
2. The Parties will file this Variation Agreement and the attached revised Tariff Schedule with the Authority in accordance with section 66 of the *Information and Communications Technology Authority Law*.
