Tariff Schedule

All tariffs in this schedule are presented excluding applicable taxes but are subject to those taxes at the prevailing rate.

Charges that are not included in this Tariff Schedule but which have been referenced from the Service Descriptions, Legal Framework or Joint Working Manual, including, but not limited to, payment for forecasts that are out of bandwidth and payment for delays in Service introduction, will be determined on the basis of all reasonable costs incurred by the Service Supplier unless it is agreed by both Parties to waive such costs incurred.

Call Durations are specified in this document as a charge of CI\$ per 60s. However, pursuant to the terms of the Service Descriptions, Calls will be measured to an accuracy of 1/10th of a second, and the Charges will be the sum of the month's measurements rounded to the nearest minute. Further detail of the billing process and procedures can be found in the Joint Working Manual.

PART 2. TERMINATION SERVICES

PSTN Terminating Access Service

The Parties agree that the rates set out below for the PSTN Terminating Access Service are interim rates until such time as the Authority determines the FTR in a follow-up proceeding after the FLLRIC model is approved. In the event that the Authority determines a rate other than the agreed interim rate, such new rate shall be applicable from 29 April 2010.

Usage Charges

Payable by Service Taker to Service Supplier. Charges for this service consist of a reciprocal PSTN Termination Charge, as well as Transit Charges. Transit Charges are applied only when the Service Supplier transits the call over its mobile network for termination on a PSTN network.

Charges for the termination of PSTN-to-PSTN and mobile-to-PSTN calls shall be the same. Both will be based solely on call duration.

Charges for the termination of fixed-to-mobile and mobile-to-mobile calls shall be the same. Both will be based solely on call duration.

Payable by Service Taker to Service Supplier. The charge for this service consists of the Incoming International Fixed Termination Rate, as well as Transit Charges where applicable. Transit Charges are applied only in the case where LIME is the Service Taker and Telco, as the Service Supplier, transmits the call over its PLMN. For the avoidance of doubt, Transit Charges shall never be deducted from the Incoming International to PSTN Termination Charge payable by the Service Taker to the Service Supplier.
