Dear Mr. Brazeau,

Cable and Wireless (Cayman Islands) Limited ("C&W") and Digicel Cayman Limited ("Digicel") are requesting that the Tariff Schedule, and in particular (1) the interim without prejudice rate for fixed to mobile termination and mobile to mobile termination, (2) the International Conveyance Assumption, and (3) the Incoming International Call Termination to PLMN rate, in the attached Interconnection Agreement dated 29 January 2004 between C&W and Digicel (the "Agreement") be designated as "confidential". We make this request pursuant to Section 3(b) and (3)(d) of the *Information and Communication Technology Authority (Confidentiality) Regulations, 2003* (the "Regulations").

C&W requests that such information be designated as confidential as its disclosure would otherwise prejudice C&W's on-going negotiations with third parties which could undermine its negotiating position and result in financial loss. Digicel requests that the information not be published as it would enable competitors to have sensitive commercial information which could put it at a competitive disadvantage.

C&W and Digicel have taken the following steps to secure the confidentiality of the information: minimizing the number of staff with access to these documents; warning staff that this information remains confidential and should not be shared with anyone outside the two companies; ensuring that these documents are stored in areas secured from access by any other person.

C&W and Digicel claim confidentiality of this information for a period of six (6) months, and are filing a redacted version of the Tariff Schedule, pursuant to Regulation 4(1)(c)(ii) of the Regulations.

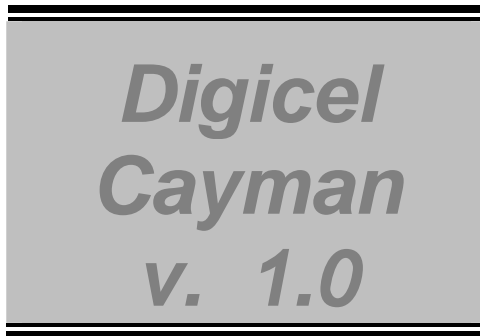

All tariffs in this schedule are presented excluding applicable taxes but are subject to those taxes at the prevailing rate.

Charges that are not included in this Tariff Schedule but which have been referenced from the Service Descriptions, Legal Framework or Joint Working Manual, including, but not limited to, payment for forecasts that are out of bandwidth and payment for delays in Service introduction, will be determined on the basis of all reasonable costs incurred by the Service Supplier unless it is agreed by both Parties to waive such costs incurred.

Call Durations are specified in this document as a charge of CI\$ per 60s. However, pursuant to the terms of the Service Descriptions, Calls will be measured to an accuracy of 1/10th of a second, and the Charges will be the sum of the month's measurements rounded to the nearest minute. Further detail of the billing process and procedures can be found in the Joint Working Manual.

Payable by Service Taker to Service Supplier. Charges for this service consist of a reciprocal Mobile Termination Charge, as well as Transit Charges. Transit Charges are applied only when the Service Supplier transits the call over its fixed network for termination on a mobile network.

Charges for the termination of fixed-to-mobile and mobile-to-mobile calls shall be the same. Both will be based solely on call duration.

The Mobile Termination Part specified below is an interim rate which is without prejudice to either C&W's or Digicel's views on the appropriate rate. The appropriate rate shall be determined by the ICTA and retrospectively applied.
