Dear Mr. Connors,

In response to your below email, I must admit it left me somewhat confused. However, it has transpired, coincidentally, that Cable & Wireless (Cayman Islands) Limited ("C&W") only received this letter, as an attachment to an email from Digicel (Ms. Nadine Ramsay ) on Tuesday October 16 2007, 12:03PM and addressed to Mr. Rudy Ebanks only, it was copied to no other person within the C&W group. This would have been the first time anyone in C&W would have received this letter from Digicel dated September 28 2007, by any means (electronic or printed).

Ironically, and noteworthy, Mr. Ebanks has been off island on company business from 13 October and will not return to office until Monday 22 October 2007. His Out of Office Assistant, which I am sure Ms. Nadine Ramsay would have received, gave clear instructions of my acting assignment and contact details, however the email was not received by me. Instead, she (Ms. Nadine Ramsay) subsequently resent the email to Mr. Ebanks' PA (October 16 2007, 4:06PM) again requesting her to forward to Mr. Ebanks' attention.

Mr. Ebanks is on business in Europe and is not in a position to check his email. I have subsequently tracked this email down, however, please be aware this is the first time I am seeing this letter and hence some 18 days later (from date of letter) that C&W is seeing this letter for the very first time.

Of interest to C&W would be to see the original correspondence from Digicel, which should have been copied to all interested parties in CD 2005-1, and whether or not we were included as a recipient.
