On 19 October 2010, the Information & Communications Technology Authority received an application by Cable and Wireless (Cayman Islands) Limited, trading as LIME ("LIME") for reconsideration of paragraphs 27 and 28 of ICT Decision 2010-9, Decision in Determination Request related to Allocation of Votes in the Number Portability Consortium. A copy of LIME's application is attached to this e-mail and will be available shortly on the Authority's web site at http://www.icta.ky/da_inp.php. The Authority invites comments on LIME's reconsideration application. The Authority invites comments on the following questions:

- Does the Authority have jurisdiction, under section 78 of the Information and Communications Technology Authority Law (2006 Revision) or otherwise, to reconsider paragraphs 27 and 28 of ICT Decision 2010-9?
- Assuming that the Authority has jurisdiction, should paragraphs 27 and 28 of ICT Decision 2010-9 be confirmed, reversed or modified, and for what reason(s)?

Pursuant to subsection 78(4) of the ICTA Law, a decision must be rendered on the reconsideration application no later than 16 November 2010. However, given the significant delays in the implementation of number portability and the narrow scope of LIME's reconsideration application, the Authority considers that a shorter timeframe is appropriate in this case. The Authority will therefore make best efforts to issue a decision by **Friday 29 October 2010**. In order to meet this deadline, the Authority sets the following schedule:

- Comments on LIME's application must be filed no later than **25 October 2010 at 12:00 (noon)**. Parties are to copy the distribution list in the "To:" and "cc:" fields above at the same time the comments are submitted to the Authority.
- LIME may file a written reply to any comments received concerning its application. This reply should be filed with the Authority, and a copy sent to the distribution list, no later than **27 October 2010 at 12:00 (noon)**.
