International Satellite by 1 December 2004.

Internet Telephony by 1 October 2004.

Internet Services and Retail Sale of ICT Equipment by 1 October 2004.

Provision of ICT Infrastructure by 1 October 2004.

AND WHEREAS TeleCayman Limited was granted a Licence dated 29 October 2003;

AND WHEREAS the Information and Communications Technology Authority is in agreement that the roll out schedule in Annex 1A be amended as requested;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2004 Revision), Annex 1A of the TeleCayman Limited Licence dated 29 October 2003 is amended as noted above.

- d) Domestic Satellite will be deployed by 1 June 2005 between Grand Cayman and Sister Islands unless agreement is reached for use of the Cayman Jamaica Fibre System;
- e) International Satellite by 1 December 2004.
