Approval of Amendment to ICT Licence

Thank you for your letter dated 29 March 2005 together with your cheque in the sum of CI\$1,500 to cover the application fee for a Type 14 – Application Service Provider Licence.

I am pleased to advise you that the Board of the Information and Communications Technology Authority (the "Authority") has favourably assessed West Indian Electronic Technologies Ltd.'s ("WIET") application for a Type 14 – Application Service Provider Licence. Please find Amendment No 1 to WIET's Licence enclosed herewith for safekeeping.

As previously discussed and as noted in your letter, the Authority requires WIET to immediately discontinue any reference to "GeoCayman" in its business operations and also to ensure that new contracts are prepared between WIET and GeoCayman Ltd.'s customers to replace such customers' contracts with GeoCayman Ltd. However, WIET may now reinstate customer access to the "WorldPay" Credit card system provided this is done pursuant to an agreement between WorldPay and WIET (rather than GeoCayman Ltd.).

Please provide us with copies of any agreements between WIET and JC Headwaters Canada Inc. or any of its affiliates, or with either Chad Gubala or Alister Ayers individually.
