



AMENDMENT NO 9 TO THE LICENCE OF WESTTEL LIMITED

WHEREAS Telecayman Limited and WestTel Limited have agreed to use the 5.4 GHz band on a shared basis in order to support their respective point-to-multipoint services;

AND WHEREAS Telecayman Limited does not object to the allocation of the 5.510-5.590 GHz frequencies to WestTel on an exclusive basis;

AND WHEREAS WestTel Limited has agreed to vacate the 5.470 to 5.510 GHz frequencies and does not object to the allocation of these frequencies to Telecayman on an exclusive basis;

AND WHEREAS Telecayman Limited and WestTel Limited have requested that their respective licenses be amended to reflect this agreement;

AND WHEREAS the Information and Communications Technology Authority concurs to amending Annex 4 of WestTel Limited's Licence to reflect this agreement;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2006 Revision), Annex 4 of the WestTel Limited is hereby amended.
