

AMENDMENT NO 11 TO THE LICENCE OF WESTTEL LIMITED

WHEREAS WestStar TV Limited is authorized to use the 2500-2698 MHz band on a non-exclusive basis in order to offer cable television services using MMDS technology;

AND WHEREAS WestTel Limited is authorized to use the 2500-2700 MHz band on a non-exclusive basis in order to offer internet and internet telephony services using MMDS technology;

AND WHEREAS WestStar TV Limited and WestTel Limited have agreed to vacate certain portions of this band to ensure that each party has unhindered access to their respective portions of this band;

AND WHEREAS WestStar TV Limited and WestTel Limited have requested that their respective spectrum in this band be allocated on an exclusive basis;

AND WHEREAS the Information and Communications Technology Authority concurs to amending Annex 4 of WestTel Limited's licence to reflect the agreed upon spectrum sharing between WestStar TV Limited and WestTel Limited, but does not concur to the allocation of this spectrum on an exclusive basis;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2006 Revision), Annex 4 of the WestTel Limited licence is hereby amended.
