

AMENDMENT NO. 26 TO THE LICENCE OF WESTTEL LTD.

WHEREAS WestTel Ltd. Doing business as 'Logic' is currently authorised under the terms of its licence granted by the Information and Communications Technology Authority now the Utility Regulation and Competition Office ('Office'), on 12 February 2004 (as amended); to supply various Information and Communications Technology ('ICT') Networks and offer various ICT Services;

AND WHEREAS WestTel Ltd and the Utility Regulation and Competition Office have agreed to extend the term of WestTel Ltd Licence to the 31 December 2020;

AND WHEREAS WestTel Ltd and the Utility Regulation and Competition Office agree that the extension will maintain the existing rights, obligations and expectations of the current licence;

THEREFORE pursuant to sections 23 and 31 of the Information and Communications Technology Law (2019 Revision), Annex 1 *Licenced ICT Networks and ICT Services* of WestTel Ltd Licence is hereby amended.

1.3 The Office shall have the right to impose upon the Licensee additional obligations concerning the Type 6 ICT Service which may include obligations pertaining to such matters as programming and content. The Licensee agrees that the Office shall have the right to impose obligations, from time to time, as are deemed advisable by the Office. The intent is for the Licensee to have similar, but not necessarily identical, obligations as any other Licensee offering a Type 6 ICT Service.

At a minimum these obligations shall involve the following:

- a) Any customer wishing to receive the Licensee's Public Television service shall be provided such service, either via wire line or broadcast technology, within a reasonable time frame and at no cost to the subscriber. This includes all manner of device required to provide service into the subscribers premises.
- b) Program content shall, at a minimum, be 20% local content which shall include such items as local talk shows, educational, cultural and religious programming, live sporting events, government information services and live coverage of the proceedings of the legislature.
- c) Public Television service shall involve programming offered 24 hours a day, 7 days a week, 365 days a year.
